President's Page- La page du président

Tempora mutantur, nos et mutamur in illis - times change and we change with them. This is true in everyday life and ranges into our hobby in several ways. Many of us have re-directed our interests, either broadened them or narrowed them; we have become more selective. This last attitude seems to dominate the scene with traditional philatelists becoming more specialized in some aspects of the country they collect; postal historians concentrating on particular eras rather than areas; aerophilatelists and thematic collectors each carving out a new niche for themselves with hitherto "hidden" specialists coming into their own; marcophilately, revenues, philatelic bibliophilia, just to mention a few.

Collecting changes have affected supply houses. The old type store caters to the broader needs of collectors by stocking the needed supplies, enlarging its inventory of products and keeping a keen eye out for items on the want lists of their customers. Many dealers tend to do well by specializing in particular fields of collecting with specialized auction houses becoming more common.

The collector should determine the best way of obtaining materials that suits him/her but it is important to deal with a knowledgeable dealer with an established reputation. You will do well by remembering to patronize dealers who support the hobby by participating in your club's exhibitions and advertise in *The Canadian Philatelist*.

Club exhibitions are a good way to promote philately in an area and thus attract new members. Dates for exhibitions should be submitted to the editor of the *CP* as soon as they become available. This will help to publicize the exhibition and avoid possible conflicts with other

Tempora mutantur, nos et mutamur in illis - les temps changent et nous avec eux. Ceci est vrai non seulement dans notre vie mais aussi dans nos passe-temps. Plusieurs d'entre nous avons changé la direction de nos intérêts, soit en élargissant nos horizons ou en devenant plus spécialisé, nous sommes devenus plus sélectifs. Cette dernière approche prédomine puisque plusieurs philatélistes traditionnels se spécialisent dans un aspect ou des aspects du pays qu'ils (elles) collectionnent; les spécialistes de l'histoire postale se spécialisant dans des périodes plutôt que des aires géographiques; les aerophilatélistes et les thématistes découvrent d'autres champs de collection et de nouveaux domaines d'études apparaissent: revenues, littérature philatélique, marcophilatélie, etc.

Les changements dans les habitudes des collectionneurs affectent aussi les marchands. Le type de magasin d'antan s'efforce de répondre aux besoins toujours grandissant de sa clientèle. Il le fait en accroissant son inventaire et en gardant un oeil ouvert pour les pièces sur les manco-listes des collectionneurs. Plusieurs marchands se spécialisent dans des domaines intéressant les collectionneurs et des maisons de ventes à en- chères spécialisés apparaissent.

Il est important que le collectionneur décide quel est le meilleur moyen pour lui/elle d'obtenir les pièces qu'il/elle a besoin. Un marchand connaissant sa matière et ayant une bonne réputation vaut la peine d'être supporté. Il vous servira de donner votre clientèle aux marchands qui participent dans vos expositions locales et qui annoncent dans *Le philatéliste canadien (PC)*.

Les expositions de club sont une bonne manière de publiciser la philatélie et d'at-



clubs in the same geographic area. National exhibitions, which attract large crowds, usually are advertised as much as two years in advance. Any club or group which deliberately selects the same days as those made known to the public is doing itself and philately a great disservice.

The Royal is undergoing changes in its administrative structure. One of the big moves, from Ottawa to Toronto, is now completed. Thanks to our administrative secretary, Miss Leslie Ireland, we have encountered few delays in establishing our new base. Correspondence is dealt with quickly and routine office work is attended to in a good, orderly manner. The place is humming, thank you Leslie!

The Sales Circuit has a new home and a new manager, Mr. George Krajewski. There is no progress report as yet since the change-over took place only recently and not all the equipment has been installed at the time of writing this message. I have no doubt, however, that everything will be in place shortly and the Sales Circuit will be making its appointed rounds.

I would like to take this opportunity to welcome George Krajewski aboard. A professional engineer, George is an accomplished philatelist and philatelic administrator. 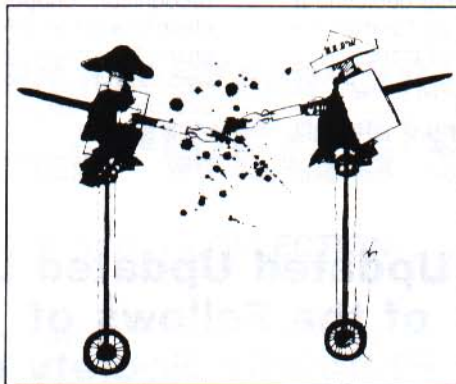

Please note that there was a minor typo in my article "Definitives of Canada: The Last Quarter Century" which appeared in the Sept.-Oct. 1991 number of *The Canadian Philatelist* in Table 5 on page 393.



The letters NPN should actually read NI under the first column 13-. In other words, the 10-cent stamp depicting a skunk appeared with a perforation 13- with the panes having no plate inscription.

It should also be noted that by "major

varieties" I am referring to well-known varieties that have largely received recognition. I hope that this will become clear in another article, on "The Landscape Definitives of Canada," that I am working on.

According to the Oriental lunar calendar, 1992 is the Year of the Monkey. The Republic of China - Taiwan - issued two stamps and a souvenir sheet on Nov. 30, 1991 as New Year's greeting stamps.

skillful, original and inventive. You are also inconsistent, troublesome, cantankerous and cunning. You love compliments, are successful at work, have an excellent memory, and are highly competent.

The Year of the Monkey occurs every 12 years. Were you born in 1908, 1920, 1932, 1944, 1956, 1968 or 1980? If so, and with whatever of the above attributes you choose for yourself - ignoring those you don't like, it is no doubt proper that you monkey around with your stamps, be it skillfully, cunningly, competently or in whatever fashion you choose.

CANADA 92

You should make a special effort to try to attend CANADA 92, the international youth philatelic exhibition to be held in Montreal from March 25-29 at the Palais des Congrès. There should be lots to see and do.

It is being organized by The Royal Philatelic Society of Canada in collaboration with Canada Post and with the participation of the Fédération québécoise de philatélie under the patronage of the Fédération Internationale de Philatélie.

His Excellency Ramon John Hnatyshyn, Governor General of Canada, will be honorary patron and will oversee its official opening ceremonies.

As of mid-December, 426 entries from 36 countries, for a total of 1,632 16-page CAPEX-style frames, had been received. Judging by some of the exhibits I've already seen, many would be highly competitive with those of adult exhibitors.

As a member of the organizing committee, I can attest to the hard work being done by many people to ensure the success of CANADA 92. Shows of this magnitude don't magically unfold overnight.



Bulletins 1 and 2 are now available.

Tourist and other information can be obtained from CANADA 92, Case postale 1992, Succursale Place d'Armes, Montréal, PQ H2Y 3L9.

The CANADA 92 catalogue will have a number of articles that should interest all levels of collectors. E.G. Bragh's "The Private Order Issues of CANADA 92 Postal Stationery" which appeared in the Sept.-Oct. 1991 number of *The Canadian Philatelist* will be updated with new information. I've prepared a piece on "Montreal: One of the Cradles of Philately in North America" which discusses some philatelic activities of Samuel Allan Taylor and John Appleton Nutter in Montreal in the 1860s. Nutter, a teenager, seems to have been the leading Montreal stamp dealer in the mid-1860s.

Canada Post, the major financial backer for CANADA 92, will issue four stamps, and a large souvenir sheet containing the four stamps, on March 25. There will be other philatelic goodies at the show.

OUR NATIONAL POSTAL MUSEUM

Elsewhere in this issue there appears a Canadian Museum of Civilization news release announcing the appointment of Francine Brousseau as Chief of the National Postal Museum.

The 1988 splitting of Canada Post's original National Postal Museum, opened in 1974, into two entities under two separate administrations was not applauded by all the philatelic community. The current National Postal Museum is, in a sense, custodian of three-dimensional postal artifacts while the Canadian Postal Archives - part of the National Archives of Canada - houses stamps and other philatelic material as well as having an extensive holding of Canadian and foreign philatelic literature.

Both entities are in dire need of space in order to be able to display more of their

holdings for public viewing. Until that space is available, I can't help but on occasion liken the two to sponges. They collect and store and preserve, but seem reluctant to be squeezed so that the public can see and can be kept fully informed about the extent of their holdings.

Now that there is no longer an advisory committee for the two with outside representation from the philatelic community to offer suggestions, I can only hope that the National Postal Museum and the Canadian Postal Archives will work closely together in staging displays and in jointly promoting our hobby and telling the broader story of the development of postal services in Canada.

I wish Francine Brousseau the best of luck in finding suitable permanent display quarters for her National Postal Museum. I have felt, perhaps wrongly, that the Canadian Museum of Civilization has not been as active as it might have been in finding such quarters for the museum. Plans for it to be housed in the Canadian Museum of Civilization's complex in Hull - a spaciouly laid out floor plan for the proposed quarters was prepared - seem not to have been followed up. Indeed, there is a possibility that the museum could in time be located back in Ottawa.

May that time - be the location in Ottawa or in Hull - be soon and may the two parts of what was once a single entity work closely together, with some advice being sought from the philatelic community.

IMPORTS FROM BEIJING?

Michael Madesker and Harry Sutherland were among the Canadians attending PHILANIPPON 91 in Tokyo in November. While in that part of the world, they flew to Beijing. I have it on good authority that neither officer of our society can be accused of bringing the Beijing flu virus on their return to Canada. They flew, but without the flu.

Themaphil

i INTRODUCTION

Canada has been represented at World/International Philatelic Exhibitions for many years. During those decades, a large number of philatelists have garnered awards and recognition in the "Traditional" branch of philately; but surprisingly only few have entered their exhibits in another branch - just as important and exciting - "Thematic".

This article has been written to foster thematic philately to the readership of *The Canadian Philatelist/Le philatéliste canadien*, the official publication of The Royal Philatelic Society of Canada.

A number of readers, from time to time, have read, with a certain degree of disapproval, about thematic collecting or perhaps have come face to face with an exhibit at one of the shows they attended which left them cold. However, due to the progress made worldwide, North American collectors are now realizing that perhaps they are missing some of the enjoyment which thematic philately brings.

This article, composed of eight sections, will be published from time to time in *The Canadian Philatelist/Le philatéliste canadien*.

ii THE SIGNET

The signet of Themaphil is a combination of the Greek letters Φ (phi) and Θ (theta) for the words thematic philately. It was adopted as the signet of TEMBAL 83 for the Fourth International Thematic Exhibition, held in Basel, Switzerland, on 21-29 May 1983.

iii ABOUT THE AUTHOR

He is also an accredited national judge (RPSC, APS, ATA), is affiliated with many societies - local, national, international - and conducts lectures at various clubs with a mission of promoting philately and exhibiting.

He is a long time collector in both branches - Traditional and Thematic - and an authority on the thematic scene for many years. His personal collections and achievements at national and international levels make him uniquely qualified to write about Thematic Philately, "Themaphil" for short.

1. WHAT IS THEMATIC PHILATELY

Recently there has been an increased tendency among philatelists to limit their collections by collecting stamps of the country of which they are citizens or by the subject or the theme that they depict.

Hence were born collections by "Subject" and by "Theme" which, as time went by, have drawn the attention of an ever increasing number of collectors. It could simply be stated that we are face-to-face not with a transient fashion, but, on the contrary, with a natural expression of our times. These innovations have been defined as "Collections of a new era".

Like all the arts and all the sciences in general, even philately has felt the need to evolve and to renew. On the other hand, it is almost impossible today for an individual to collect "worldwide" or restrict a collection to a continent. New issues, as we all know, are countless and to obtain them all would be very costly. Thus, truly specialized and personal collections are reaping success along with traditional collections. During the last couple of decades, thematic collecting

has progressed in an astonishing manner and has affected, with a greater certainty, the future of philately.

Thematic collecting is free. It is not bound by any catalogue, and the collector can impress upon the collection of the subject or theme chosen his/her own arrangement, character, personal taste and above all the exclusive cultural tendency. In fact, one of the most attractive aspects of thematic philately is the privilege that each collector has to determine the amplitude and the limits of the collection and to include or to exclude what one desires.

Up to now we have talked about "Subject" and "Thematic" collecting without distinction. However, between the two types a substantial difference exists that, more often than not, escapes the novice or the advanced collector. In truth, the definitions given by many are not too clear, and still misunderstandings remain in persisting to confuse "Subject" with "Theme" collecting. All of this is because many philatelists don't pay much attention in distinguishing first of all what are the meaning of the words "Subject" and "Theme".

"Subject", in philatelic terminology, is the study of the vignette or design of the stamp. One could arrange all the subjects that relate to, for example, flowers, animals, sports, paintings, etc. and form a "Subject" collection of floral, zoological, sports, artistic, etc. topics (Fig. 1). The "Subject" collection should logically be accompanied by brief explanatory notes describing the subject which they represent.

When however we propose to develop philatelically a "Theme" we should collect stamps which, even having the most dissimilar vignettes, are ideally bound together by a guiding thread. In other words, in the case of the "Theme", the illustration of stamps should serve only to develop a theme, just like an essay. For example, if the topic that we are dealing with is "The First World War", the approach in this case is to collect stamps

which represent the places, heroes, politicians, warlike equipment, monuments, armed forces, historical rivers, etc. which recall in some way the War of 1914-18 (Fig. 2). Evidently the development of the theme should be contained within the limit of stamp collecting, but dealing with a cultural form of collecting. The development should be in accordance with the importance of the selected theme.

Thematic collections are also called "ideological" or "constructive" and should always be accompanied by an explanatory text that is invariably succinct and concise.

Now that the difference between "Subject" and "Theme" collections has been explained let us give the official definition. In the regulations promulgated by the Thematic Commission of the Fédération Internationale de Philatélie (FIP) we read:

A "Subject" collection is a philatelic assembly having for base of classification the subject which illustrates the stamp. It consists in a single juxtaposition of stamps and philatelic items having a certain relation between them for the subject which is represented.

A "Subject" collection is:

- a limited collection with only a subject where, in its presentation, items are classified by country and in chronological order of issue,
- a limited collection with only a subject which, in its presentation, is similar to a general collection.

A "Thematic" collection is a philatelic assembly elaborated according to a determined plan. It develops a theme, presents a thesis, illustrates a constructive idea with postage stamps and other philatelic items.

Given the enormous number of collectors who dedicate themselves to this branch of philately, many national and international societies have emerged. Some of the principal ones are:

American Topical Association (ATA), FIP

Thematic Commission, Society of Olympic Collectors (SOC), Centro Italiano di Filatelia Tematica (CIFT), Société Suisse de Philatélie Thématique (SSPT), Associacao Brasileira de Filatelia Tematica (ABFT), and Thematic Society of Australia (TSA).

2. THE EVOLUTION OF THEME CONCEPT

We will probably never know who was the first collector interested in the picture on the stamp. The first stamps showed the portrait of a sovereign, local coats of arms or even a mere number corresponding to the postage rate for a letter. Actually we find even other designs on these first stamps, which we could classify nowadays as thematic ones.

In 1843 the famous "Double Geneva" represented the origin of a very important event in thematic philately with its inscription "J.H.S." = Jesus, Saviour of Men and the text "Post Tenebras Lux" = After Darkness, The Light. On the Western Australia 1854 a swan symbolizes the Swan River, and on the Canadian stamp of 1851 there is a beaver (Fig. 3). It was a brilliant idea not to consider stamps as a mere payment of postage but as a support for an image and a message. Postal Administrations contributed to spreading this concept by now and then using cancellations with still another purpose than the mere obliteration of the postage stamp.

Nowadays, the situation is completely reversed; most of the stamps issued show a specific topic, and only the definitives still feature heads of states or numbers. New perspectives open up to the philatelists, for now he/she can unfold his/her personality.

The thematic collection is a philatelic entity which illustrates an idea or develops a theme according to a logical plan. On the one side it calls for deep and detailed research on the theme, with logical subdivisions, which are frequently based on a personal view; on the other side the development of the idea leads back to

philately, because the collector finds out that he/she needs all types of philatelic elements to effectively support the idea and especially to reinforce his/her personal opinion.

At this point, the thematic collector discovers the world of philately. Space and time no longer exist for him/her. An old or classic stamp can be shown side by side with a recent issue; a Norwegian and an Argentinian stamp can be placed together, a stampless cover (from the pre-stamp era) fits in with a modern cancellation.

There is only one rule in thematic philately: all stamps and philatelic elements must be related to the same theme and collaborate to the development of the plan. For instance an historical description of the medical arts (Fig. 4), which, proceeding from mythology and the ancient physicians, leads us to the discovery of the human body and its illnesses and illustrates the fight of humanity against sickness and death. It continues on with the chemical formula of medicine, a hospital in the jungle, or even the latest modern technology: a helicopter for air rescue or an ambulance with life-saving equipment. Another example would be the development of navigation (Fig. 5), beginning with the early boats, sailing ships, paddle-steamers to the nuclear-powered submarines. The purposes of navigation would follow with the transportation of people and goods, forwarding of mail and the use of sails and the story of expeditions. Naval and sea battles would also have to be explained.

All fields of human activity such as science, history and art can be developed into thematic collections.

To define philately, and especially thematic philately, merely as a leisure-time activity is demeaning it. The essence of thematic philately is far more than that; it calls for uninterrupted research work and for a continued

cultural contribution. Otherwise the philatelist must be compared to the so called "arm chair sportsman" who is satisfied with observing the events from his seat at the arena or from his chair in front of his television set.

Thematic philately enriches even more than a visit to a museum, reading of a book, or listening to a concert. Together with traditional philately it covers a wide range of cultural aspects.

The regulations for thematic philately are the result of a long evolution of thematic philately itself, which has eliminated the problems and has developed step by step towards an independent form of philately. After having mastered many difficulties, thematic philately has now achieved its aim and is accepted by philatelists all over the world.

3. KNOW YOUR THEME

Building up a thematic collection requires an enormous amount of knowledge related to the history of, for example, the Olympic Games. But then, one has to make the right choice of what part of that knowledge should be used for the development of the theme.

The main object of thematic philately is to tell the story of a chosen subject with philatelic material. When displaying a collection, one should strive to ensure that all the information conveyed in the write-up is as accurate as possible. The search for the correct information can be just as interesting and as rewarding as the search for the correct philatelic material.

Research and write-up when examining a stamp

Write-ups should only be included if one can show philatelic material to connect them. Let us take, for discussion purposes, the stamp issued by France for the 1960 Olympic Games held in Rome, showing the athlete J. Bouin. Where do we put this stamp? Under Rome 1960? Under France? Or under Stockholm

1912, where Bouin participated in the 5,000 metre race? Certainly, from a thematic point of view, the stamp should figure in the chapter on "Olympic Medallists" of 1912.

Where should one look for the correct write-up? The obvious source would be the official report (English version) where one will find all the details of the 5,000 metre flat race on pages 366-68. Not being in possession of this report should not be a handicap, since this famous race is described in many general books on the history of the Olympic Games.

What would be a succinct write-up?

"J. Bouin, France, won the silver medal in the 5,000 metre race. His time: 14'36,7/10".

One could extend the write-up, but in this case more philatelic material is necessary in order to overpower the stamp with too much text. One could, for instance, use the black die proof, with the following write-up:

"J. Bouin, born 20 December 1888, was killed in World War I on 19 September 1914. He was beaten on the finish line in the 5,000 metre race. Three days later, he abandoned in the middle of the 8,000 metre cross country race, and did not show in the 10,000 metre race" (Fig. 6).

You have some more material? A colour essay or an "Épreuve de Luxe"? This could be put on the same page with the following write-up:

"J. Bouin had already participated in the 1908 Games. On 16 November 1911, he established the first official world record for the 10,000 metre in 30'58,4/5". (In fact, one could use the Bouin stamp when documenting the London Games of 1908). (Fig. 7).

Yes, know your theme, but only use this knowledge when you can connect it with corresponding philatelic material. Unsupported facts convey nothing and should not figure in the collection.

Research and write-up when examining a text or a picture

Let us examine the problem from another angle. To be consistent, I shall remain with Bouin. In 1958, I consulted a catalogue on sports and Olympic stamps. A footnote on a page attracted my attention. It stated that the seven cent stamp of the Barranquilla set issued by Colombia in 1935 shows the victory of Kohlemainen of Finland over Bouin of France in the 5,000 metre race, in Stockholm, 1912.

In my collection of the official cards of 1912, there is a picture of the finish corresponding, as it should, to the picture to be found in the official report. The picture showed the finish, but Bouin was still in the lead. Doubt now existed in my mind. Was the footnote correct, or just a fantasy? In fact, using a magnifying glass, one can distinguish two rings on the athlete's shirt, which corresponds to the shirt worn by Bouin in the race. Still, as far as I was concerned, no pictorial proof existed that tied the Colombian stamp to Bouin.

In 1976, Raymond Marcillac, a French sports journalist, published a book entitled *Champions olympiques*. To my surprise and satisfaction, I had found my proof. A picture on page 29 showed the finish of the race as it was seen on the Colombian stamp. It all fitted together now.

What write-up should one use? Where should one place this stamp? Obviously, the stamp could also be used to illustrate the 1912 Games in the chapter on "Olympic Medallists". The write-up could be:

"The finish of the 5,000 metre race on 10 July 1912, won by Kohlemainen, Finland, in 14'36,6/10", a new world record. Runner up, and silver medal, J. Bouin of France. In 1935, Colombia honoured this race on the seven-cent stamp in the Barranquilla issue".

One may use the Colombian stamp in an alternative way. Suppose you happen to

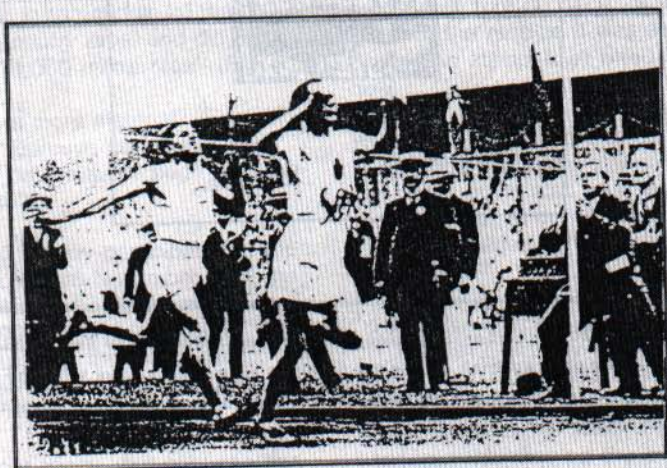

have an item posted on 10 July 1912. You could combine that item with the Columbian stamp under the chapter entitled "The Olympic Programme".

The write-up could be:

"10 July 1912, 12th day of the Games, Official Post Card showing the Olympic publicity cancellation of the day of the race. The Programme: One of the events was the final of the 5,000 metre race. The finish is shown on the stamp of Colombia" (Fig. 8).

Should you feel that the page is somewhat naked, with just one card and one stamp, then add some other stamps. Their date of issue is of secondary importance to documenting the various events of this day. The above examples show that thematic development can be made in different ways. The only requisite is that the write-up should be accurate and in complete accordance with the philatelic material shown. The choice, however, on how to show thematic development is not limited, and the collector can use his imagination to give the collection his personal touch.

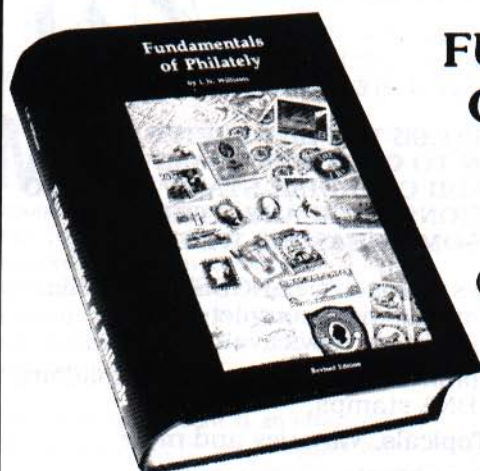

Canadians and Armed Conflict (Part 1: to 1758)

by C.F. Black

Note: Unless otherwise specified, all catalogue numbers are from the Scott Standard Postage Stamp Catalogue.

Much of Canada's history has been shaped by incidents of violence in which we, as individuals, groups or as a nation have resorted to arms to assist causes in which we have believed. There have been more than a million of us who have become actively involved in these confrontations, here and elsewhere, and over 100,000 have lost their lives.

The following account is an attempt to link our wars and lesser struggles with such of the postal issues of Canada and other countries as can be shown to have a relationship to these unhappy events.

There have been human inhabitants in North America for more than 10,000 years. An early settlement is represented on Canada 1104, but records are scant for the long period before the arrival of the first Europeans on our shores about 1,000 years ago.

We do know, however, that these early peoples, tribes and families were wont to engage in warfare for cultural, economic or personal reasons.

Among their customary weapons were bows and arrows, which have achieved heraldic recognition in the Arms of two of our Provinces. One of the supporters in the Arms of Nova Scotia, pictured on Canada 420, is "holding in the exterior Hand an Arrow proper," and on the Arms of Newfoundland, on Canada 427, are two Beothuks "armed and apparelled in their guise when they go to war."

Another common weapon was the club, shown on two Canadian stamps, 563 and 571, the one on the latter being made of

whalebone. A special type of club, the tomahawk, is found on Czechoslovakia 1401.

One of Canada's greatly admired poetesses, the daughter of a Mohawk chief, wrote expressive verses on inter-tribal warfare. She was Tekahionwake, better known as Pauline Johnson, the centenary of whose birth was marked by Canada in 1961 with a stamp, 392, showing her portrait.

Her father, Onwanonsyshon (G.H.M. Johnson), was the head of the Six Nations Indians. He had married an Englishwoman, Emily Howells, who gave birth to their daughter at their home, Chiefswood, on the reserve bordering the Grand River near Brantford, Ontario.

She wrote such lines as:

"Armed with the ancient weapons of
his race,
A slender ashen bow, deer sinew
strung,
And flint-tipped arrow each with
poisoned tongue,-
Thus does the Red man stalk to death
his foe."

For a much different reason a long ornamented tobacco pipe also warrants mention; it is the calumet, the pipe of peace, one of which is on Canada 563. Its function was to be smoked and passed around among those who were negotiating an end to a quarrel.

The Norsemen

During the latter part of the tenth century and the early years of the 11th, Norsemen became the first Europeans who are certainly known to have sailed along our coasts. Their ships are on a number of postal issues, among them Canada 1105 and Ghana 14.

Their first landfall was probably Newfoundland's Great Northern Peninsula, which is considered by authorities to be the long promontory at the lower left of the map shown at the left of Iceland 391. This map is a 1668 copy of an original map of 1590 which has been lost. It had been prepared at the time a search for the lost colonies in the new

world was being initiated. The copy of 1668 is now in the Royal Library in Copenhagen.

The earliest Norsemen who came here are not, as far as I know, represented on stamps. The first to be honoured was Leif Ericsson, who appears, for example, on Hungary 2533a and his is the statue on stamps on Iceland B6 and on United States 1359.

Ericsson came here, probably in the year 1000, and it is thought he first stepped ashore at L'Anse aux Meadows (Bay of Jellyfish). An excavation on this site is featured on Ethiopia 999, the 1b of the World Heritage year set issued in 1981,

and a typical foundation of a Viking house, such as might be found here, is seen on Faroe Islands 82, the 2k of their Europa set of 1982. Leif and his men remained at this location on the Great Northern Peninsula for perhaps a year. The Norsemen called the natives they found here the Skraelings, or yelling savages. These were likely Beothuks, as on Canada 427, and for those interested in



watermarks they are also, in outline, to be seen in the paper of Newfoundland 172-82, etc. Although Leif and his crew are not definitely known to have been embroiled in violent incidents with the Skraelings, the name they gave them suggests that relationships were not friendly. A further indication of the strength of their feelings is given on the 1668 map on Iceland 391, where the Peninsula and the adjacent mainland is given the name "Skralings Land." A map of Leif's voyage is seen on Iceland 214.

In 1004, Leif's brother Thorvald outfitted a ship such as the one seen on Ghana 14 and sailed to the same place; they did not start off on the right foot, for they wantonly killed some of the natives not far from L'Anse aux Meadows. In turn they were attacked by the Skraelings, and Thorvald was himself killed.

An Icelander, Thorfinn Karlsefni, a statue of whom is shown, e.g., on Iceland 215-6, was the next to come, in about

1008, and attempt to establish a colony near L'Anse aux Meadows, and a later one at White Bay. They and the Skraelings renewed the earlier hostilities; during the first of these encounters, the Norsemen panicked and ran until one of their women, Leif's half sister Freydis, took charge and, bared to the waist, waving her sword and 'yelling like a hellcat,' so alarmed the natives that they fled.

During their later years in the colony on the Peninsula, the settlers tended to split into two factions. This led to an incident in 1014 in which Freydis again came to

the fore. Tempers had been completely lost when her party went on a rampage during which the men killed all those in the other group and Freydis herself is said to have killed all the women.

When the survivors of Karlsefni's original colony decided to vacate it they began by taking revenge on the Skraelings, killing a number of them in their sleep and moving on to a temporary camp for the winter, before finally setting sail; but that winter was also an unhappy one, for there they quarreled much among themselves.

While en route home they captured two native boys in Markland (Labrador) who told them of an old oral tradition of an earlier lost colony. Their story was that these colonists were also white and yelled loudly what sounded like "Ireland the Great" (in a language not specified) and carried poles with pieces of cloth attached, i.e., flags. This tale brings to mind the old story that the Irish monk, St. Brendan, who is seen on Ireland 601 (and a boat of the type he would have used is on an Antigua \$5 of 1991) came to this new land in the sixth century during a seven-year voyage in the western ocean with 17 fellow monks. If the Irish yelling so impressed the Skraelings that the story was passed down for hundreds of years it must have indeed been a startling experience.

Some Later European Explorers

In May 1497, the Genoese native John Cabot sailed from Bristol, England, for the New World. As far as I am aware, no portrait of Cabot is seen on any stamp. The man labelled "CABOT - HYM THAT FOUND THE NEW ISLE" on Newfoundland 62 is not John; it is thought to be his son Sebastian. He was carrying with him letters patent from King Henry VII, pictured on Newfoundland 74, which called on him to take possession, in Henry's name, of any new lands he found.

His ship was the 50-ton *Mathew*, representations of which are found on Canada 282 and 1106 and Newfoundland

68 and 270. He made landfall, probably on Newfoundland's Great Northern Peninsula, on June 24, a date now celebrated in Newfoundland as Discovery Day, and he duly claimed the land for Henry.

Cabot is not known to have explored inland, indeed his instructions to his crew were not to move farther from shore than the range of a crossbow. Nor is there any surviving account of any hostile reception from the natives. There may, nevertheless, be grounds for speculation, based on the following story. In 1501 the crew of one of Caspar Corte-Real's ships kidnapped four Beothuks from the Newfoundland coast and carried them to Lisbon. Among the possessions they treasured were part of a broken gilt sword of Italian manufacture, and silver earrings made in Venice, which lead one to the reasonable conclusion that they must have belonged to Cabot or a member of his crew.

Jacques Cartier, seen, for example, on Canada 97 and France 296-7, made three voyages to Canada, in 1534, 1535 and 1541, and during the latter two he built three forts at Stadacona (Quebec), having sensed that Iroquois distrust of the French was growing. The forts helped, but during their last winter there the natives kept the settlement in a state

of siege, and are reported to have killed more than 35 of the Europeans before Cartier left Canada for the last time in June 1542.

An Elizabethan buccaneer, also called a "sea dog of high order," Martin Frobisher, who appears on Canada 412 and Great Britain 665, sailed down the Thames in May 1576 with three ships in search of the North West Passage. Only one of his ships, the 25-ton *Gabriel*, completed the westward passage.

When they reached the mouth of what is now called Frobisher Bay they observed what they took to be porpoises or seals, but they turned out to be Inuit in kayaks, such as on Canada 351. Five of his men went ashore, but failed to observe due caution and were captured by the Inuit. During an attempt to rescue them, Frobisher and his men had to admit defeat; during this set-to, Frobisher himself was a casualty, suffering an arrow wound in a buttock. Later, on the occasion of another landing by the sailors, a group of Inuit fiercely assaulted them with "bows and arrows."

No Englishman ever saw the missing five again, but amazingly their fate became known outside the Inuit community nearly 300 years later. In 1860, an American explorer heard from an old Inuit woman their story that had been passed down over the centuries. The men had been kept as prisoners for five years, then freed; they built a boat, set sail and disappeared, presumably having perished at sea.



Another Englishman sailed westward in June 1583 armed with a royal charter to find, colonize and govern lands not colonized by any Christian prince. He was Sir Humphrey Gilbert, and anniversaries of his taking possession of Newfoundland for Queen Elizabeth were commemorated by Canada 994, the 400th, and Newfoundland 212-25, the 350th.

Four of Gilbert's five ships reached Newfoundland, the *Raleigh* having turned back to England. Newfoundland 219 mistakenly shows all five entering St. John's harbour.

Two incidents illustrate the forthright customs of Gilbert's day. One of his four ships had undertaken "a little piracy" against fishing craft engaged in their legitimate trade not far from St. John's, for which its captain was removed from his command, and one of the laws promulgated by Sir Humphrey provided that anyone who uttered words to the dishonour of Her Majesty would have his ears cut off.

Finally, in the year 1610 Henry Hudson, in a venture commemorated by Canada 1107 and Great Britain 666, set out in the 55-ton *Discovery* on a voyage, marred by internal discord, during which he hoped to find the elusive North West Passage.

They got as far as James Bay, where they spent the winter. In the following spring they attempted to explore inland, but the Inuit set the woods on fire and harassed any who set foot on shore. The crew became unruly, and before long a mutiny developed and Hudson, his son and seven members of the ship's company were set adrift in the shallop. The *Discovery* sailed away, and the unfortunate nine were not seen again.

While en route home some of the mutineers landed on Digges Island, near the eastern entrance of Hudson Bay, where three of them lost their lives during a scuffle with the natives. Only eight of them survived to see England again, and when they did land they were thrown into prison.

Quebec and Southwestward

The founder of the French settlement at Quebec, in 1608, was Samuel de Champlain, the name given to a portrait on Canada 97 etc., and on France B305. That on Canada 97 is, however, not of Champlain, but is a likeness of an unscrupulous comptroller of finances for King Louis XIV, one Particelli d'Emery.

Champlain had first seen the site of Quebec in 1603 when, possibly as Royal Geographer to Henry IV (having previously served as a sergeant in the King's army), he had sailed up the St. Lawrence. In 1604-7 he was back in North America, but not at Quebec. He was exploring the coast from Acadia as far south as Cape Cod.

In July 1608, back in North America, he fixed on the site of Quebec, founded the settlement and gave it its name. During the next spring he joined a war party of Algonquins, Canada 566-9, and Hurons, discovered the lake that bears his name and near the present Ticonderoga helped his friends win a victory over the Iroquois, Canada 578-81, by killing two of their chiefs with his arquebus.

From the beginning he had erected defensive works at Quebec, including moats and stockades, as the Iroquois were distinctly unfriendly. In 1609, on returning from France, he had another confrontation with them, and was wounded by an arrow that split his ear and cut his neck.

From 1612 until his death in 1635 he occupied a senior position, and from 1629 he was commander "in the absence of my Lord the Cardinal de Richelieu," who is portrayed on, e.g., France 304.

He met the Iroquois again, for instance, in 1615, when he and his Huron allies attacked them near Onondaga, but they failed in their assault, and he was again wounded twice by arrows, having to be carried for some days on the back of a Huron brave "like a little child in swaddling clothes."

He felt humiliated in 1629, when an English fleet under Sir David Kirke appeared off Quebec and Champlain, whose defences had grown weak, capitulated.

One of those associated with Champlain at that time was Étienne Brulé, the subject of Canada 1126, who spoiled their relationship by entering Kirke's service. Champlain accused him of treason. Brulé went to live with the supposedly friendly Hurons, but within four years they turned against him and, in the words of his biographer, "killed and ate him."

One of the fortified buildings built at Quebec under Champlain's direction was "L'ABITATION DE QUÉBEC," which is seen on Canada 99 with a gun firing over its ramparts toward the St. Lawrence.

Additional defences were erected after Champlain's death in 1635. A plan of the settlement of the early 1700s identifies 12 of them in Lower Town and on the heights - forts, bastions, redoubts, enceintes and batteries; they would have been in existence in the Quebec of 1700 that is shown on Canada 101.

A young man who came to Quebec in

1640 is part-subject of Canada 1127. He was Médard Des Groseilliers, who by 1645 had become a part of the Jesuit mission of Huronia, probably serving as a soldier helping to defend it against the Iroquois. He later became an explorer and an originator of the Hudson's Bay Co. He has another passing interest for this account, for in 1647 he married Hélène, the daughter of Abraham Martin, after whom the Plains of Abraham are thought to have been named. Radisson, the other name on 1127, was an adventurous colleague of his exploring and Hudson's Bay days.

One of the Orders that spread the Christian message among the Indians of New France was the Society of Jesus, the Jesuits. They and the Sulpicians and Récollets, as well as Ste Marie Among the Hurons, are remembered on Canada 1129. It has a special significance for the Jesuits because of the five crosses in the background, relating to an incident that is also represented by five crosses on Vatican C81. The latter was issued to commemorate the visit to Canada of Pope John Paul II in 1984.

The story of the five crosses, one of the best known of those days, concerns the



fate that befell the Jesuit mission to the Hurons in 1649, when the Iroquois almost destroyed the community. The five crosses represent five of the Jesuits that lost their lives. During his visit, the Pope visited Midland, Ontario, where there is a Martyrs' Shrine dedicated to the five, who in 1930 were canonized by the Roman Catholic Church.

During the 1650s, the Iroquois conducted a war of ambush that kept the settlers in a state of tension; even Montreal, which had begun as a religious colony, became a fortified town with a military garrison. In 1653, when seen from a vessel in the river, it looked deserted, for all the inhabitants were indoors.

The critical importance of Montreal gave great significance to an exploit in early May 1660 by Adam Dollard, Sieur des Ormeaux, who with his sword is seen on Canada 390. This commemorates the 300th anniversary of his heroic defence of an improvised fort at the Long Sault on the Ottawa River. He, with 16 French volunteers and 42 Huron and Algonquin Indians held out for five days against the determined assaults of 700 Iroquois. They were then overwhelmed, but their heroism so impressed the Iroquois that they did not for some time harass the St. Lawrence settlements.

His contemporaries regarded Dollard and his party as the saviours of the colony. In 1977 the Historic Sites and Monuments Board placed a commemorative plaque at Carillon, near the site of their heroic stand.

Even convents in the larger settlements were not spared from the Iroquois

harassments. The first Ursuline Order of Canada had in the 1640s established a convent in Quebec, and one of its founders and first Mother Superior, Marie de l'Incarnation, honoured on Canada 886, suffered much from them. Until she died in 1672, at age 72, she experienced devastation of the Order's farms, defended the convent itself from attack, and saw some of her servants killed.

Another of the outstanding figures of this turbulent period was, of course, Louis de Buade de Frontenac et de Pallau, who was Governor General of New France from 1672 to 1682 and from 1689 until his death in 1698. The tercentenary of his first appointment was commemorated by Canada 561, and the following year Saint-Pierre & Miquelon issued a Frontenac stamp, C52.

Before coming to Canada, Frontenac had been a soldier, rising to the rank of brigadier. In Canada he had complete control over military matters, and organized and mustered war parties against both the English, who were contesting the French presence, and the Iroquois. In 1690, for example, he overcame a land attack, a rather feeble one it turned out to be, by troops that had appeared before Quebec in a fleet under Sir William Phips.

He found that attempts to appease the Iroquois only encouraged them, and he gradually became more aggressive. Even at age 73, in 1696, he personally led a force of over 2000 men, although at times he had to be carried in an armchair. On this occasion, however, they proved elusive, burned their villages and vanished into the woods. His party suffered only four fatalities, and of these three were accidental.

Another soldier of this period to be honoured on one of our stamps was Pierre Gaultier de Varennes, Sieur de la Vérendrye, who is pictured (in another capacity, as an explorer) on Canada 378. He was born in Trois Rivières in 1685, and while still a youth became a soldier. He first saw action during the American

phase of the War of the Spanish Succession, which broke out in 1702. By 1704 he was still in the Canadian militia, campaigning in Maine and Massachusetts. The next year he was fighting in Newfoundland. In 1707 he went to France, where he served in Flanders with the Regiment de Bretagne, and he was severely wounded and taken prisoner at the battle of Malplaquet in 1709. It was after all this that he became the fur trader and explorer seen on the stamp.

In 1753, the British Governor of Virginia, Dinwiddie, was building a fort at the confluence of the Allegheny and Ohio Rivers when it was attacked and captured, before it was completed, by the French force from Montreal. The French rebuilt it and gave it the name Fort Duquesne, in honour of Duquesne de Menneville, Governor of New France in 1752-5. The British tried to recover it in 1755, but failed; three years later, however, they succeeded in getting it back, an occasion commemorated on its bicentenary by the United States with a stamp, 1123, picturing some of the victorious British, including the 26-year-old George Washington (on horseback in the foreground) with the fort in the background in flames, it having been set ablaze by the departing French.

Another fort, built by the French in 1755 at the junction of Lake Champlain and Lake George to protect Crown Point on the probable route the British would take en route to Canada, is also seen on a U.S. stamp, 1701, issued on its bicentenary. This was Fort Carillon, later to be called Fort Ticonderoga. Its plan, shown on the stamp, was drawn by a French-Canadian military engineer, Michel Chartier de Lotbinière, who based it on

the fortress at Metz, France.



A strong British force attacked Fort Carillon in 1758, but the French garrison succeeded in repelling them. The French commander was the Marquis de Montcalm, whose portrait is seen on Canada 100 and St.-Pierre & Miquelon C52; the following year the British were in turn to defeat Montcalm on the Plains of Abraham.

Acadia

One of the earliest names that we come across in the European settlement of this part of the country is Samuel de Champlain, Canada 97 etc. and France B305, who in 1604 accompanied Pierre du Guast, Sieur de Monts, who had been granted privileges and fur trade monopolies; Champlain's role was as a geographer.

In the following year, they arrived at the site of Port Royal in the Bay of Fundy, of which later views are found on Canada 1051 and a 1930 post card, Webb 107, giving it its name and establishing a settlement, stockaded and surrounded by strongpoints. This settlement was attacked and destroyed in 1613 by a British force from Virginia commanded by Samuel Argall. A few years later the British were to build their own fort here.

Port Royal was restored to France in 1632, and during the following decades it was to change hands several more times, by capture or treaty, the latter usually as a part of a wider international rearrangement of possessions. An example of this was the 1667 Treaty of Breda, the subject of sets issued to mark its tercentenary by Antigua 193-4, and Surinam 349-51. Under its provisions



England gave its Acadian possessions to France in exchange for the islands of Antigua and Montserrat and part of St. Christopher.

Port Royal finally became British in 1710, when it was captured by British and New England troops. It was then renamed Fort Anne (Canada 1051) and the nearby town became Annapolis (now Annapolis Royal) in honour of Queen Anne.

For a few years afterwards it was still subject to attack by French and Indian raiding parties, but always unsuccessfully. The garrison was finally withdrawn in 1854. The earthworks and the original buildings still surviving there are the oldest in Canada outside Quebec.

About 1680 French settlers first came to Grand Pré seen on Canada 176 and the 1972 post card Webb VC57, near the present town of Wolfville. In 1704 the growing settlement suffered a destructive attack by New England troops who ranged through the vicinity destroying property and crops and breaking the protective dykes.

By the Treaty of Utrecht in 1713 England gained all of Acadia, and by 1730 most of the French settlers had pledged conditional allegiance to the British Crown. But peace was elusive, for in 1747 the French attacked and defeated the New England garrison, but held it for only a short period. The French settlers this time refused to take a required oath of allegiance, thus leading in 1755 to the forcible deportation of some 6000 of them to British colonies further south along the Atlantic seaboard.

It was this event that inspired Longfellow, whose portrait is on U.S. 864, to write one of his best known poems, *Evangeline*. The site of the church where most of the deportees were gathered is believed to be in Grand Pré National Historic Park, which is pictured in part on Canada 176 and the post card VC57. A statue of *Évangéline* is seen in the foreground of Canada 176; it is the work of Philippe and Henri Hébert, and was unveiled in 1920.

Île Royale (Cape Breton Island) became the site of another French colony in 1713, when they founded Louisbourg, which soon became an important military base, the strongest and most costly fortress in North America. A major fortification programme was undertaken in 1719, and it took about 20 years to complete. When all this activity was going on the lighthouse pictured on Canada 1032 was also constructed, in 1734.

This major French outpost was attacked by a New England force with British naval support in 1745 and surrendered, but was given back to France by the Treaty of Aix-la-Chapelle in 1748. Ten years later it was again captured by a British force under General Amherst. Two of the British naval ships supporting this assault were to be awarded the battle honour LOUISBURG 1758 for their contribution - the *Namur*, on Anguilla 129 and the *Vanguard*, St. Kitts 38. The fortress was then completely demolished.

The British concluded in the late 1740s that they needed a counterpoise to Louisbourg, and in 1747 built a bastioned fieldwork at Halifax, on Citadel Hill; Canada 283 reproduces a Jeffries painting showing the scene of its construc-

tion. The present Citadel, completed in 1862, is on 988.

That work and its successors on the site, including the present Citadel, were never to be attacked, but it was continuously garrisoned until 1906 and was manned during both World Wars. In World War I it was, however, destined to play a role in preserving part of the city, as will be related.

Halifax, in its strategic position and dominated and defended by its Citadel, was once called by Rudyard Kipling "The Warden of the Honour of the North."

During these strenuous times the British also built a fort at the head of the Bay of Fundy, Fort Lawrence. In the early 1750s, to counter it, the French, on the other side of the little River Missaguash, constructed Fort Beauséjour, seen on Canada 992 and the 1930 post card Webb 156, not far from the present village of Aulac.

In June 1755 an attacking force of British regulars and Massachusetts volunteers came up the Bay and laid siege; the Fort surrendered, and the British strengthened it and named it Fort Cumberland.

A painting now on display in the Fort illustrates an interesting aspect of warfare in those days. It shows a British deserter in the then Fort Beauséjour about to be returned to Fort Lawrence. The practice that had been adopted by the rival garrisons called for the exchange of

deserters to discourage troops from "going over the hill."

Fort Beauséjour is now a National Historic Site.

Newfoundland

The French in 1662 founded a settlement at Plaisance (Placentia) on the south coast of Newfoundland; the appearance of Placentia in the 20th century is the view seen on Newfoundland 143.

Thirty soldiers accompanied the settlers and quickly fortified the site by building a stronghold, Le Vieux Fort, as a base and check against English expansion on the Island.

In 1691 these first fortifications were replaced by Fort Louis, and the next year another defensive work, Fort Royal, was commenced there on Castle Hill. This fort as it was in the early 1760s is pictured on Canada 1053. The sites of all these defensive works are within the boundaries of Castle Hill National Historic Park.

These defences faced a British fleet in 1695, and were able to repel it. The next year the French in turn, under d'Iberville, were successful in attacking the British capital, St. John's. Then and on two later occasions the main fort, Fort William, was taken and the town destroyed. A view of an old battery overlooking St. John's, presumably in the same location as a defensive work of those early days, is pictured on a 1972 Canada post card, Webb VC52.

Vignettes of Early British North American Postal History

by J.C. Arnell, F.R.P.S.C.

Part X1X: Office Hours, Couriers & Mail Bags at Way Offices

The last Vignette described the handling of the Mails at the smaller post offices. Further aspects of the operation of these offices are discussed here and show what an onerous task being a postmaster was.

On 2 April 1832, the Deputy Postmaster General called the attention of the postmasters at the *Way Offices*, defined as those situated between any of the principal Post Towns, "to the expediency of regulating and publishing, from time to time, the hours at which the Mails are to be closed at their respective Offices.—Owing to the state of the roads at particular periods of the year, the Couriers cannot possibly arrive at the several Way Offices with uniform regularity—on many occasions there must be considerable delay. In the winter, when the sleighing is fine, great expedition is practicable in the transportation of the Mails, and at this period, in order to facilitate the arrival of the General Mail at the end of the route, (an object which every Post Master should consider of paramount importance,) the Mails at the Way Offices should be closed sufficiently early to prevent the chance of delaying the Grand Mail;—But the hour that would be suitable for closing at that period, would be found quite too early in the Spring and Autumn, when the roads are deep and heavy, and the time necessarily occupied in the conveyance of the Mail is considerably more than at other seasons.—This difference in the time occupied in the transit of the Mails, increases towards the end of the Post Routes, and it thus becomes necessary to regulate the hours for closing the Mails at the Way Offices according to the seasons and the state of the roads."

The instruction went on to indicate that

the Deputy Postmaster General could only give general instructions on the subject and must leave the determination of the closing hour to individual "judgment and discretion". While stating that the convenience of the Public must be the first consideration, they were told that the closing hour should be well "in advance of the probable time of the arrival of the Stages or Couriers, within specific periods or seasons of the year", and once fixed must not be changed without due notice being given to the Public. The final admonition (in italics) was:

"It must never be lost sight of by Post masters at all Offices, that on no account is the Mail to be despatched by them earlier than the published hour for closing."
[Think of what all this means in terms of what hours of the day or night a postmaster may have to work.]

Turning to the matter of the couriers and mail bags. In 1827, postmasters were instructed to ensure that couriers and all other persons, except those with a legal right to be present, be excluded when Mails were being made up or mail bags opened. Eighteen months later, they were told that, if any large parcels of



clothing or other items were found in mail bags on arrival, they were to be removed and retained, while the Deputy Postmaster General was notified. The only exception was bags or packages of coins being remitted to the General Post Office.

In 1832, the instructions were issued covering four specific points. The first concerned the situation when a Mail Portmanteau arrived unlocked. In this case, the courier or driver was to be strictly interrogated as to the cause, and to record the results on the Road Bill or in a special report to the postmaster in charge of the route. In addition, a list was to be made of all the packets found in it, the destination offices, and, if possible, the offices of origin. This was intended to help decide whether a robbery had taken place. It was noted that this would delay the courier, but "it is better that the Mail should be delayed than exposed to depredation." A new lock was to be applied and, if such was not available, the bag was to be secured with the Seal of Office—noting same. Should the bag be defective in any way, it was to be repaired or replaced with a new one.

The second concern was with letters or newspapers arriving wet and damaged. In this case, they were to be dried, recovered and readdressed before the courier was allowed to proceed on his way. If the fault appeared to lie with the courier, this was to be reported.

The next dealt with a courier arriving intoxicated. In this case, the postmaster was to "engage some steady honest man as an extraordinary Courier, and send him forward with the Bags to the end of the Route, or until he shall meet with another Courier or Driver belonging to the same line, to whom he can hand over his charge". There was to be a standing rule: "*Never to entrust a Mail to a man who has ever disgraced himself by being intoxicated whilst in charge of a Mail.*" There are many reports of intoxicated couriers in the post office records. Having regard for the conditions under which

many of them had to operate, it is not surprising to find that many took to drink to keep warm or keep out the damp!

Finally, it was directed that, in the event of a courier falling ill, a Special Courier was to be engaged under the same conditions as above.

It would appear that there must have been some trouble over responsibility for the handling of the mail bags at way offices, for in 1836 it was laid down that, on arriving at an office, a driver, post rider or courier was to carry the Mail Bag or Portmanteau into the room where the Office was kept and deliver it or them to an authorized person; and when the Mail was ready to leave, it was to be delivered to him in the Office or at the door, and he was responsible for it from then until it was handed over at the next office.

As a collector of stampless letters, I never cease to be amazed at the amount of work that individual postmasters did in just handling the letter passing through their offices—checking them, rating them for distance, stamping them, and packaging them. When all the record-keeping in manuscript was added to this, one may wonder how they ever finished their day's work.

Fellows of the Society

**George Carlyle Marler,
PC, BCL, LLD
1901-1981**



The Honourable George Marler, membership number 9439, was elected a Fellow of the Society in 1972.

George Carlyle Marler was born in Montreal on September 14, 1901, a descendant of a British Army Officer who arrived in Quebec in 1808. George Marler was educated at Selwyn House School, Bishop's College School, the Royal Navy College, and McGill University where he received his civil law degree. He was awarded honorary degrees from McGill University and the Université de Montréal.

An ardent philatelist, Mr. Marler was noted for his research and writings on the Admirals and the Edward VII issues. Publication of his first book *Canada - Notes on the 1911-25 Series* was made

in 1949. In 1975 his beautifully illustrated book *The Edward VII Issue of Canada* was published and has received many awards, world wide, for its excellence. It was very sad indeed that he did not live long enough to see his masterpiece *The Admiral Issue of Canada* published in 1982. As the Admirals were Mr. Marler's first love in philately, it is significant that both his first and last books were about them. Also, he contributed many well-researched articles to *The Canadian Philatelist*, *B.N.A. Topics*, *The American Philatelist*, *Maple Leaves*, *The Collectors Club Philatelist*, *The Essay Proof Journal* and the Postal History Society of Canada's *PHSC Journal*.

Mr. Marler had a political career on the Montreal city council and in the provincial and federal legislatures that lasted from 1940 to 1966. Although he left active politics in the middle sixties, he maintained a keen interest in public life. Mr. Marler became Chairman of the Board of the firm Ciments Lafarge Québec Ltd. He was senior member of the Notary firm of Marler, Tees, Watson, Poitevin, Javet & Roberge, Montreal. He served on the board of the Canadian Imperial Bank of Commerce, the Royal Trust Company Limited, the Royal Trust Mortgage Corporation, and the Ontario and Quebec Railway, etc. Also, he authored many reports and treatises, writing in either English or French. Among the better known is his great reference work, *The Law of Real Property - Quebec*, written in 1934.

Besides being named a Fellow of The Royal Philatelic Society of Canada, The Honourable, and very much respected, George Marler, was honoured by being named a Fellow of The Royal Philatelic Society, London, and a Fellow of The Canadian Philatelic Society of Great Britain. He was a former Director of our



Society and, for a number of years, he served as a member of Canada Post's Stamp Advisory Committee. He also belonged to a number of other philatelic societies.

Although writing absorbed much of his leisure time, he was an ardent golfer, a horticulturalist, and an expert photographer.

Mrs. George Marler, the former Phyllis Walker, passed away in 1985. They are survived by three daughters and one son.

For a change of pace, what follows is a reprint of an 1864 article in French — with a bit of Greek for good measure! — that contains the initial reference to the term "philately".

The reprint appeared in the March 15, 1902 number of *The Montreal Philatelist* (Vol. 4, No. 9), published by W. James Wurtele and edited by F.W. Wurtele, both of Montreal. James Wurtele, manager of the International Stamp Company — in Montreal at the time — was apparently associated with the same company in Quebec City in 1872, and in that year was, it is said, editor of the second periodical to have the title of *The Canadian Philatelist*. It was published in 1872 and 1873 in Quebec City and lasted for four numbers.

Here, then, is the reprint, "From the Original Source" as it was titled in *The Montreal Philatelist*, with introductory editorial comments by one or the other of the Wurteles.

...

Several of our readers have asked us to reproduce Mons. Herpin's original article giving its modern name to postage stamp collecting. The article appeared in *Le*

Collectionneur de Timbres-Poste, Nov., 1864, and we are indebted to the courtesy of Mr. H.E. Deats for a copy, in the original French, which we take pleasure in reproducing in this number.

Previous to the appearance of this article the only name given to stamp collecting was *Timbromanie* and it was to combat this contemptuous term that Mr. Herpin wrote. Mr. E.D. Bacon's book, "The Stamp Collector," is guilty of two blunders in this connection, it gives the date of the new name as 1865, whereas it was invented in 1864. It also erroneously states that "Timbrologie" was the term first of all employed. We have looked through many files of old French and English magazines and can find no mention of this word. It may have been suggested somewhere, but was certainly not generally used by any writer. It was introduced at a much later date by Dr. LeGrand (the precise date perhaps one of our French readers can inform us) because that eminent authority did not consider that the term "philately" comprised anything but postage stamps.

It will be noticed that Mons. Herpin translates the Greek word by the French term "*affranchi*" literally "set free," but commonly applied to a prepaid letter.



And he gives the signification of "Philately" as the love of the study of all that relates to "affranchissement," that is the franking or prepayment of the postage of a letter.

There is not one word in the article to indicate that the inventor applied the term to the payment of taxes which are indicated by fiscal stamps, and as we have before remarked, such an application is a flagrant misconstruction of the Greek, that would not be excusable in a first year Greek student.

BAPTÊME.

N'est-il pas étrange que depuis six ou sept ans que l'on s'occupe de l'étude et de la recherche des timbres-poste, on n'ait pas encore songé à donner un nom à cette attrayante occupation qui fait le bonheur des uns et la fortune des autres? Il est impossible de regarder comme une dénomination acceptable le mot *timbromanie*. Ce n'est en effet qu'un terme légèrement injurieux que certaines gens, en croyant faire un mot, articulent avec une intention sarcastique d'un effet d'ailleurs assez innocent. C'est donc faute de mieux qu'on l'a employé jusqu'ici; mais il est temps de bannir ignominieusement de notre vocabulaire; bien plus, lecteurs et écrivains de ce recueil, nous devons nous efforcer d'oublier cette odieuse expression et de douter même de son existence. Maintenant, en admettant que la bête soit morte et le venin aussi, il faut lui trouver un successeur qui n'ait rien de commun avec elle et qui même compte autant de qualités qu'elle avait de défauts. Mais où trouver cet oiseau rare? Chacun pouvant donner son avis sur cette grave question, et la fortune favorisant les audacieux, nous nous hasardons à formuler ici notre opinion.

Tout le monde a pu remarquer que la plupart des mots nouveaux avaient pour racine des mots anciens, sans doute à cause de l'affinité que les extrêmes ont les uns pour les autres; or, les néologismes empruntant leurs éléments aux Latins et aux Grecs, nous allons tenter aussi une incursion dans l'un de

ces idiomes. Nous entendons déjà les cent voix de la critique nous crier:

Qui nous délivrera des Grecs et des Romains!

Nous bravons ces vaines clameurs, nous poursuivons notre carrière, selon l'expression de M. Baour-Lormian, et nous nous disons que puisque la numismatique a tiré son nom du latin *numisma*, médaille, et la sphragistique (étude des sceaux, sans jeu de mots) du grec σφραγιζω, *je scelle*, nous pouvions aussi, vu sa richesse, faire quelque emprunt à cette langue généreuse et proposer aux amateurs le mot: *Philatélie*, comme exprimant l'idée que le terme odieux stigmatisé plus haut s'efforçait de ridiculiser.

Philatélie est formé de deux mots grecs: φίλος ami, amateur, et ἀτελης (en parlant d'un objet) franc, libre de toute charge ou impôt, affranchi: substantif: ἀτελεια *Philatélie* signifierait donc: amour de l'étude de tout ce qui se rapporte à l'affranchissement.

Maintenant, puisque le mot est lâché et que le nouveau-né a vu le jour, en vue d'augmenter ses chances de bonheur et de prospérité, nous prions instamment nos jeunes et charmantes lectrices d'en être les marraines. Eh quoi! dira-t-on, vous parlez grec aux jeunes filles? C'est choisir un singulier moyen pour leur plaire et demandeur leur patronage. Le moyen n'est peut-être pas si mauvais que vous le supposez. Qui sait si l'étrangeté même de la requête ne sera pas sa meilleure recommandation. A qui donc, d'ailleurs, une chose nouvelle, un mot nouveau, peuvent-ils demander aide et protection, si ce n'est à la jeunesse amie des nouveautés en toute chose, et dont les faibles imploront bien rarement en vain la générosité? Du reste, au nom du grec, nous n'affichons aucune des folles prétentions du Vadius de notre Molière. C'est donc sans témérité, mais aussi sans embarras que nous sollicitons l'approbation de la plus belle moitié du genre humain, sûrs que nous sommes, si nous l'obtenons, de celle de l'autre moitié.

En définitive, nous n'imposons rien; seulement la lice étant ouverte, nous attendons, nous sollicitons même les communications qui auraient trait à cette question, nous déclarant d'avance tout prêts à nous ranger à l'avis d'un *Philatélie* mieux inspiré.

The Richard K. Malott Collection on the Development of Canadian Air Mail Services - La collection Richard K. Malott de documents sur le développement du service aéropostal canadien

The bush pilots have always been a romantic part of Canadian history. The Canadian Postal Archives is pleased to announce that it has acquired the Richard Kenneth Malott collection of manuscripts and photographs that document the development of air mail services in Canada, and the role these pilots played. Malott created the 54 box collection during his 30 years of researching, collecting, writing, exhibiting, and organizing in Canadian philately and aerophilately.

Major Malott explains "I've collected stamps from an early age. An interest in stamp collecting, an Honours History degree from the University of Western Ontario, and a career in the RCAF all came together in my decision to collect all aspects of Canadian aerophilately including Canadian pioneer, semi-official, and official air mail, crash covers, Canadian aerogrammes and Canadian Forces air letter forms. Starting with an award of participation I slowly worked up to the F.I.P. Championship Class. Thus there was method in my madness."

The Malott archive will be of value to researchers interested not only in Canadian aviation and philately, but also in promotional art, and in the history of northern and isolated parts of Canada. The papers, photographs, and a few covers are organized in eight series. Perhaps the most valuable is the "Pilot Series" of Malott's correspondence with nearly 200 early pilots. Most of this correspondence was during 1960-1962, and through it

Après avoir obtenu un prix de participation, j'ai progressé peu à peu dans le domaine jusqu'à la classe des maîtres de la F.I.P. J'étais méthodique dans ma folie."

Le fonds Malott présente une grande valeur pour les chercheurs qui s'intéressent non seulement à l'aviation et à la philatélie canadiennes, mais aussi à l'art de la communication ainsi qu'à l'histoire



Malott acquired copies and originals of letters, photographs, and newspaper clippings documenting their historic flights, as well as many personal accounts and anecdotes about the beginnings of Canadian air mail service.

Other series document Malott's work with various philatelic societies and his involvement in Canadian and international exhibitions, and another series consists of his philatelic correspondence. One of the more unusual features of the collection is the large number of airline timetables and other ephemera. The most valuable aspect of this material, which is throughout the papers, may be the logos, commercial images, and layout. They allow one to see the evolution of the promotion of aviation. Finally there are three series of files on a broad range of aviation and philatelic subjects: postmarks, stamp design, rates, new issues, first flights, aerogrammes, meter slogans, semi-official air stamps, military post offices, conventions, and commemorative covers. These files, covering a wide range of subjects, will be of interest and use to many philatelists.

NEW STAMPS HONOUR CANADIAN MEN AND WOMEN IN DANGEROUS OCCUPATIONS

OTTAWA (September 13, 1991) – Four new commemorative 40¢ stamps to be issued on September 23, 1991 provide a fascinating look at four of *Canada's Dangerous Public Service Occupations*: firefighting; police; search and rescue; and the ski patrol. These occupations demand a high level of fitness, determination, life and death decision-making and offer, in return, action, adventure and the deep satisfaction of helping others. The stamps will be unveiled at a ceremony held in conjunction with an international convention of fire chiefs taking place in Toronto on September 22.

Firefighting is often regarded as North America's most dangerous occupation, due to the great risks involved for professional or volunteer firefighters. Firefighters rescue people from high rises, extract injured people from car wrecks, and administer first aid. Their occupation demands both scientific and technical expertise.

Each day, Canadian police officers face physical danger while upholding the law. Today's environment, as characterized by larger cities, reflects cultural diversity, more sophisticated criminals and rapid social change. Canada's law enforcement

OTTAWA (le 13 septembre 1991) – Le 23 septembre 1991, on lancera quatre nouveaux timbres commémoratifs de 0,40\$, qui donneront un aperçu captivant de quatre *occupations dangereuses*: lutte contre les incendies, police, sauvetage, et patrouilleurs-secouristes. Ces métiers exigent une grande forme physique, de la détermination, des décisions vitales, et offrent en contrepartie action, aventure et la profonde satisfaction de venir en aide à son prochain. Le dévoilement des timbres se fera au cours d'une cérémonie tenue à l'occasion d'un congrès international des chefs de service d'incendie à Toronto, le 22 septembre.

occupation has a colourful history; the Royal Canadian Mounted Police was established in 1919 while municipal police forces did not appear until 1930.

Search and rescue was a necessary feature of early Canadian life. Today, the demand for services is still heavy, and technology helps to deliver rescuers on target faster than ever before. Numerous organizations concern themselves with search and rescue, including volunteer groups, police forces, Parks Canada, the Armed Forces, the Department of Fisheries and Oceans and the Canadian Coast Guard, among others.

In 1940, Dr. Douglas Firth and the Canadian Amateur Ski Association (CASA) organized a first aid and rescue group to patrol ski hills in the Laurentians. In 1961, the Canadian Ski Patrol System (CSPS) became independent of the CASA. Since then, the CSPS has more than 5,000 trained patrollers who possess life-saving skills including accident prevention and safety, accident management, evacuation procedures, search and rescue, and avalanche safety. 1991 marks CSPS's 50th anniversary as an independent, largely volunteer, operation.

Suzanne Duranceau of Montreal designed these four stamps. The colour and realism of the scenes stress the drama of each of the occupations depicted.

Official first day covers will bear a Toronto, Ontario cancellation and a cachet featuring a colour photograph of firefighters at work.

FOUR TALL TALES FOCUS OF SECOND CANADIAN FOLKLORE ISSUE

OTTAWA (September 13, 1991) – The first stamp issue of October – Folktales – presents the second set of four stamps in the Canadian Folklore series. These four new 40¢ stamps highlight the Canadian folktales of *Buried Treasure*, the *Chinook*, the *Witched Canoe* (or *La Chasse-Galerie*), and the *Orphan Boy*. Folktales have a unique place in our culture; they entertain, enlighten and often act as cautionary tales.

Nova Scotia abounds in tales of *Buried Treasure*. One of the most famous, that of Oak Island, has been cloaked in mystery and drama since its discovery in 1795. Over the years, a mysterious pit has drawn scores of fortune seekers lured to the island by tales of fabulous treasure buried there by the notorious pirate Captain Kidd. So far, treasure-seekers have come up empty-handed.

Tall tales about the warm dry wind called a *Chinook*, which blows eastward out of the Rockies, are no less amazing than the facts. In minutes, the warm breath of the chinook was believed to make the deep snow of Southern Alberta disappear as if by magic. One storyteller claimed that a chinook melted the snow so quickly that, while the front runners of his sleigh slid over the snow, the back runners stirred up a cloud of dust!

Quebec's *La Chasse-Galerie* (or the *Witched Canoe*) is a 19th century humorous cautionary tale. It recounts how a pact with the devil, made on New Year's by lovesick lumberjacks allowed them to fly home in canoes to their

QUATRE RÉCITS FABULEUX AU CENTRE DE LA DEUXIÈME ÉMISSION SUR LE CANADIEN

OTTAWA (le 13 septembre 1991) – La première émission d'octobre – Contes populaires – présente le deuxième ensemble de quatre timbres dans la série du folklore canadien. sweethearts far away. The story, while entertaining, also served to admonish blasphemers and those who would stray from the teachings of the Church.

The chilling Inuit legend of the *Orphan Boy* named Kaujjakjuk is used by the Inuit of Labrador as a moral warning by parents to teach children not to mistreat others. Kaujjakjuk overcomes abuse to gain revenge upon those who mistreated him. The story is full of magic, animals (dogs and polar bears) and provides a fascinating look at Inuit cultural values.

All four folktales can be read in their entirety in a new Souvenir Edition, which also contains four mint stamps and an Official First Day Cover. It sells for \$7.95 (plus applicable taxes).

The Official First Day Cover will bear a Calgary, Alberta cancellation and a cachet featuring an illustration of a colourful map depicting Oak Island, Nova Scotia.

Designer Ralph Tibbles teamed up with illustrators Allan Cormack and Deborah Drew-Brook, all of Toronto, to create these colourful stamps. The scenes in the foreground of the stamps are animated while a larger figure in the background looks on.

UNQUENCHED FIRE: CANADA'S SECOND PRESTIGE BOOKLET CELEBRATES 150th ANNIVERSARY OF QUEEN'S UNIVERSITY

OTTAWA (September 27, 1991) – On October 16, Canada Post Corporation will

La terrifiante légende inuit de l'*orphelin* Kaujjakjuk sert aux parents inuit du Labrador de leçon pour enseigner à leurs enfants à ne pas maltraiter autrui. Kaujjakjuk réchappe de mauvais traitements et prend sa revanche sur ceux qui l'ont maltraité. Le récit est plein de magie, d'animaux (de chiens et d'ours blancs) et donne un aperçu fascinant des valeurs culturelles inuit.

issue its second Prestige Booklet, commemorating Queen's University's place in Canada's educational system and its 1991 sesquicentennial. The booklet contains ten 40-cent stamps and a written text explaining the history of the distinguished university. The stamp will be unveiled on October 16 (University Day) at the Principal's Reception in Grant Hall, Queen's University, Kingston, Ontario.

The booklet is called *Unquenched Fire*, named for a quote by Leonard Brockington, rector of the university from 1947-1966, who said, "The history of this university is the story of a fire that would not be quenched." The stamp shows Grant Hall Tower, an icon at Queen's since 1905, named for George Monro Grant, one of the school's most influential principals. The stamp was designed by Les Holloway and Richard Kerr of Toronto.

From the first handful of students studying in a rented house in 1842 to the current student population of 17,000, Queen's has seen much progress in the last 150 years.

In the fall of 1841, Queen Victoria granted a charter to the Reverend Thomas Liddell to establish "Queen's

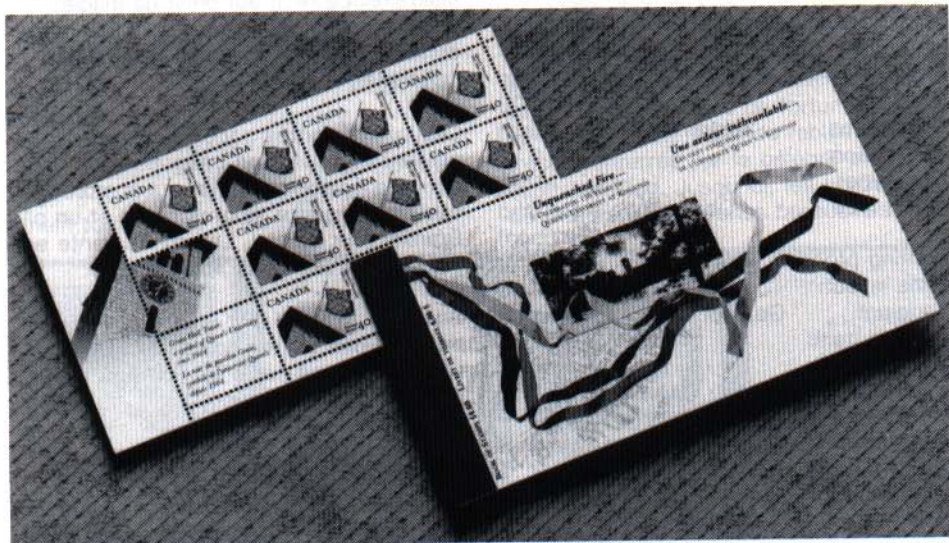

L'université Queen's a beaucoup évolué au cours de ses 150 années d'existence, depuis les premiers cours donnés à une poignée d'étudiants dans une maison louée, en 1842. Aujourd'hui, elle compte 17 000 étudiants et étudiantes.

À l'automne 1841, la reine Victoria accorde au révérend Thomas Liddell une chartre créant «le collège Queen's à Kingston». Après de nombreuses difficultés financières, la nouvelle institution décerne ses premiers diplômes en 1847.

Pendant son mandat de recteur de 1877 à 1902, George Grant fait du collège Queen's une université d'envergure nationale qui offre non seulement des programmes en arts et des cours d'études supérieures, mais également des cours de médecine et de sciences. Aujourd'hui, le pavillon Grant est perçu comme le symbole architectural des réalisations de cet ancien recteur.

SANTAS FROM AROUND THE WORLD TOPIC FOR 1991 CHRISTMAS STAMPS

OTTAWA (September 27, 1991) – Canada Post Corporation's traditional Christmas commemorative stamp issue this year features four versions of Santa Claus as he is recognized in different parts of the world. Four stamps will be issued October 23, in denominations of 35, 40, 46 and 80 cents.

For the sixth year, Canada Post is offering special Greet More stamps for use on domestic greeting cards. The stamps are available at the reduced rate of 35 cents and are sold only in booklets of ten. They are used in conjunction with specially marked greeting card envelopes that permit more efficient mail processing.

The stamps were designed by Steven Slipp, a Halifax graphic designer. Slipp's Santa figures were first constructed from torn paper for a collage effect, and then scanned by a computer and manipulated so they could be reduced to stamp size.

The 40-cent domestic rate stamp shows the popular North American Santa Claus. He is presented on the stamp in his familiar red suit and black boots, filling a Christmas stocking and carrying his bag of presents.

Santa Claus came to North America in the 1650s, when Dutch immigrants introduced "Sinterklaas", who visited children the night of December 5. In 1664, the name was anglicized to Santa and his visited moved to Christmas Eve. He evolved from the European tradition of St. Nicholas, who was based on a philanthropic bishop from the fourth century.

The 35-cent Greet More stamp depicts Great Britain's "Father Christmas" who brings gifts for every stocking and Yule logs for the hearth. Unlike St. Nicholas-based Santas, Father Christmas evolved from pagan festivals that took place around the time of the Christian feast celebrating the birth of Jesus Christ. He is shown on the stamp holding a wassail

The 80-cent stamp, the rate for mail going to international destinations, shows "Sinterklaas", of the Netherlands, one of the St. Nicholas "Santas" common to many European countries. He was renowned for giving generously to the poor – and for doing so in secret at night. He is shown in a bishop's miter, carrying a crook and giving gifts to a child.

The Official First Day Cover will bear an Ottawa, Ontario cancellation and a cachet featuring an early 20th-century portrait of the North American Santa Claus.

BASKETBALL CENTENNIAL AND ITS CANADIAN INVENTOR TO BE COMMEMORATED ON STAMP, SOUVENIR SHEET

OTTAWA (October 11, 1991) - On October 25, Canada Post Corporation will issue a special 40-cent stamp and a souvenir sheet celebrating one hundred years of basketball, a game invented by Dr. James Naismith (1861-1939), originally from Almonte, Ontario.

Basketball fans across Canada will be able to see these new stamps on October 27, during the half-time broadcast of an NBA Exhibition game in Toronto. The stamp will be featured by The Sports Network (TSN) and le Réseau des sports (RDS), official sponsors of the issue.

In conjunction with the stamp presentation, a *Heritage Minute* about the invention of basketball and its Canadian creator will be premiered during the broadcast. *Heritage Minutes* are 60-second telefilms about Canadian historical topics and are produced by the CRB Foundation and sponsored by

80 cents. The central element of each features a dynamic, stylized illustration of players involved in various actions seen in a game, as though captured for a single moment in time.

The souvenir sheet will also be unveiled on October 26 at Naismith Memorial Public School in Almonte.

Joseph Gault, Charles Reynolds and Tiit Telmet of Toronto designed the stamps and souvenir sheet, which are meant to suggest the skill and action of basketball. On the souvenir sheet, Naismith himself overlooks the scenes being played out on the stamps.

James Naismith was a doctor, teacher and theologian from Almonte, Ontario, near Ottawa, who excelled in his studies and in sports. At the suggestion of the Montreal YMCA secretary, Dr. D.A. Budge, Naismith registered at the Young Men's Christian Association Training School in Springfield, Massachusetts. It was at the training school that Naismith was challenged to create a game for the school's most rebellious gym class.

Using the restricted winter space of a gym, Naismith combined factors from outdoor games to create a new sport to amuse the students. He decided the new game would require a large, light ball which could be thrown but not carried, to force players to throw with skill rather than force. Each facet of the game was tailored to minimize roughness. Two peach baskets were nailed on either side of the gym and two teams of nine players tossed up a soccer ball.

The first game took place on December 21, 1891 and was christened "basket-ball" after the inventor modestly rejected the name "Naismith ball".

TOTAL WAR: SET OF FOUR STAMPS FOCUSES ON THE SECOND WORLD WAR IN 1941

OTTAWA (October 11, 1991) – On November 8, Canada Post Corporation will issue the third set of stamps in a series commemorating the Second World War. Entitled *Total War*, the set of four 40-cent stamps looks at different aspects of the war in 1941, the year the hostilities grew to include Japan, the United States and the Soviet Union.

The stamps depict the defense of Hong Kong, women in the armed forces, war industry, and veterans and cadets.

In 1941, the British government requested that Canada send troops to Hong Kong to defend it from the Japanese. Two battalions were sent, The Royal Rifles of Canada and the Winnipeg Grenadiers. Though having fought valiantly, the under-equipped and under-trained troops suffered a crushing defeat when the Japanese invaded on December 8. The design shows three Canadian soldiers manning an anti-aircraft position at Hong Kong.

The role of women in the armed forces is commemorated with a stamp showing members of the three women's branches of the armed forces: the Canadian Women's Auxiliary Air Force (later the Royal Canadian Air Force, Women's Division), the Canadian Women's Army Corps, and the Women's Royal Canadian Naval Service. Also shown on the stamp is a "nursing sister", the term for nurses serving with the armed forces, who often worked close to the front to treat the wounded.

LA GUERRE TOTALE: JEU DE QUATRE TIMBRES CONSACRÉ À LA SECONDE GUERRE MONDIALE

OTTAWA (le 11 octobre 1991) – Le 8 novembre, la Société canadienne des postes émettra le troisième jeu de la série consacrée à la Seconde Guerre mondiale. Intitulé *La guerre totale*, ce jeu de quatre timbres de 0,40\$ rappelle différents aspects de la guerre en 1941, année pendant laquelle le Japon, les États-Unis et l'Union soviétique prennent part aux hostilités.

Les timbres ont pour sujet la défense de Hong-Kong, les forces armées féminines, l'industrie de l'armement ainsi que les vétérans et les cadets.

En 1941, le gouvernement britannique demande au Canada d'envoyer des troupes à Hong-Kong afin de défendre le pays contre les Japonais. Deux bataillons s'y rendent: le *Royal Rifles of Canada* et les *Winnipeg Grenadiers*. Bien qu'elles se défendent vaillamment, les troupes, mal équipées et mal entraînées, subissent une défaite cuisante lors de l'invasion des Japonais le 8 décembre. Le timbre



A third stamp looks at the changes to Canadian industry and the workforce during the war, when new factories sprang up practically overnight to meet the overwhelming demand for war material. One of the most dramatic changes to the workforce occurred as a result of the labour shortage brought on by the war, when women were increasingly called to work in previously male occupations. The stamps shows male and female workers assembling an anti-aircraft gun in an artillery factory.

The fourth stamp focuses on veterans and cadets, who also played a significant role during the war. Many veterans of the First World War, who failed to meet the age or health requirements for the second conflict, were able to serve in the veteran's organizations such as the Veteran's Home Guard (later the Veteran's Guard of Canada), which helped provide guards for factories, prisoner of war camps, and other sites.

Members of cadet corps, whether army, navy or air force, receive a wide variety of instruction in military and leadership skills, and often choose to serve their country in the military, as many did dur-

The Judging Column - La rubrique du juge

This month's column will deal with Philatelic Literature Exhibitions. I will bring you up to date on two new policies which were approved by the Board of Directors of The Royal Philatelic Society of Canada (R.P.S.C.). They deal with the regulations for national philatelic literature exhibitions and the criteria required to become a national philatelic literature judge.

...

Regulations concerning the holding of National Philatelic Literature Exhibitions in Canada

BACKGROUND: For some time, there has been a need to provide a framework for the exhibiting and judging of philatelic literature in Canada. From time to time, philatelic literature sections have appeared at National and Regional level shows in Canada. Philatelic judges are used to evaluate the entries and, in general, they are left to their own devices as to the relevant criteria. This situation is not deemed acceptable to organizers, exhibitors and judges themselves as it does not allow for fair and equitable judging of philatelic literature in Canada and does not allow for exhibitors to be given encouragement, support and an appropriate evaluation before venturing into international waters. Therefore, the following regulations became effective in May 1991 with the holding of Canada's First National Philatelic Literature Exhibition at ORAPEX '91 in Ottawa.

DEFINITION: A National Philatelic Literature Exhibition is defined as: A philatelic literature exhibition accredited at a national level by The R.P.S.C. and meeting the criteria established or revis-

VENUE: A National Philatelic Literature Exhibition can be held at the same time as an accredited National Philatelic Exhibition or independently from any stamp show. As well, should it be more practical, a National Philatelic Literature Exhibition may be held by mail.

CRITERIA: The following criteria are required to be met, by a Philatelic Literature Exhibition, to obtain national level accreditation:

- a) The exhibition must be comprised of at least four of the following categories:
 - Handbooks, Monographs, Pamphlets and Studies,
 - Catalogues (other than Auction Catalogues),
 - Newsletters or Periodicals of National or International Societies or Groups,
 - Newsletters of Study Groups,
 - Commercial Philatelic Newspapers or Periodicals,
 - Articles, Series or Columns in the Philatelic Press,
 - Articles, Series or Columns in the non-Philatelic Press,
 - Club Newsletters,
 - Show Programmes, and
 - Other;
- b) It must have 24 or more entries;
- c) It must be judged by a separate jury of *qualified* national or international literature judges. The jury must be composed of at least two judges and one apprentice. The full panel must be approved, in writing by the Chairman of The R.P.S.C.'s Judging Programme;
- d) All entries must be accepted if they meet the requirements stipulated in the exhibition's prospectus;
- e) Entries written in English or in French must be accepted. Entries in other languages may be accepted if a member of the panel of judges is conversant with the language in which the exhibit is written; and,

Canadian Accreditation Programme for Philatelic Literature Judges

BACKGROUND: As for the creation of national level philatelic literature exhibitions, there is a need to regulate philatelic literature judges so as to ensure that we provide the philatelic community with the best trained and experienced individuals available. Previously, philatelic judges, in general, had little experience and were not trained in the area of philatelic literature. If The R.P.S.C. is to accredit National Philatelic Literature Exhibitions in Canada, it must ensure that there is a core of qualified judges. As well, such a core would allow for the training of new judges and increase the Canadian pool of judges from which prospective international philatelic literature jurors can be chosen.

CRITERIA: A national level philatelic literature exhibition judge is one who meets the following criteria and is accredited at a national level by The R.P.S.C. through the Chairman of the Judging Programme.

- a) Philatelic literature judges must meet the following criteria;
- Two (2) apprenticeships and one (1) invited judgeship (or a third apprenticeship) at a National Philatelic Literature Exhibition;
 - A national level medal for philatelic literature received as a writer and/or editor; or have a record of writing and/or editing philatelic literature that satisfies, in either case, the Judging Programme Committee; and,
 - Have followed a philatelic literature judging seminar.
- b) Accredited national level philatelic judges wishing to be accredited for philatelic literature must meet the following criteria:
- One (1) apprenticeship at a Na-

EXEMPTION: A one-time grandfather clause has been approved by the Board of Directors of The R.P.S.C. which allows already accredited national level philatelic judges to qualify as national philatelic literature judges as long as they have met the following criteria;

- A national level medal for philatelic literature received as a writer and/or an editor; or have a record of writing and/or editing philatelic literature that satisfies, in either case, the Judging Programme Committee; and,
- have followed a philatelic literature judging seminar.

All existing accredited national level philatelic judges can avail themselves of this one-time opportunity. It expires May 1, 1992 and judges would have to write to me to indicate their interest before that date. However, judges wishing to avail themselves of the grandfather clause would have until January 1, 1994 to meet all the criteria they are missing for accreditation as a national philatelic literature judge.

Colour matching is a function of quality control. It appears that there is little quality control exercised by the Bank Note Companies. Of course quality control costs money. Looking at some recently issued stamps one can see variations in colour shades which would indicate lack of any colour matching procedure. Maybe this gives some extra items for our collections and is done purposely to encourage us buying these varieties?

...

Ray Horning came up with two new rather strange mailing labels. The first one, re-addressing a letter, shows a yellow orange label with a computer number AUTOMATED MAIL (MUM) and a bar code. What MUM means is not known. The second one, again redirected mail, carries a yellow label with a long computerized number and a bar code with the new address. The first label has the bar codes in black by a machine. The second label has various, normally seen on mail, in red, yellow or black. The first label is always used above the second yellow one but the yellow one is used alone.

...

An attempt has been made by Ralph Trimble to classify all re-entries. This is not an easy task and he certainly needs all the encouragement he can get. For the field this writer is especially interested in, the Admirals, such a re-entry classification may look like this:
Class 1 - significant doubling of the major

parts of the total design (Major Re-entry).
Class 2 - significant doubling of some parts of the design but not of the entire design (Strong Re-entry).

Class 3 - doubling of limited parts of the design, such as top, bottom, numeral boxes or spandrels (Normal Re-entry).

Class 4 - slight doubling of some parts of the design (Minor Re-entry).

Class 5 - weak or limited doubling affecting only small parts of the design (Very Minor Re-entry).

...

Erwin Oberholzer in Bern, Switzerland, is the director for a paper restoration organization. It repairs old documents using the latest chemical, electronic and mechanical equipment. His experience stems from the paper making industry. Restorations are made to old, important documents, letters, covers. Although stamps or philatelic material are not directly mentioned, the article in the Bern newspaper appears to indicate that this kind of material can be restored by this organization. Cleaning and repairing covers and stamps has been practised for years and the question has always been to what extent this kind of repair is acceptable without becoming an item of doubtful origin. The techniques used by such an organization would suggest that the results are almost perfect restorations and that detection is almost impossible.

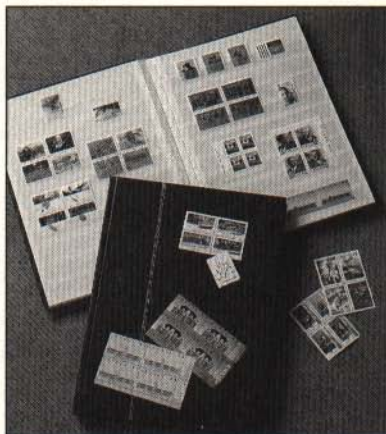
